**AN ORDINANCE LEVYING A PROPERTY TAX RATE FOR THE YEAR 2013;
DIRECTING THE TAX ASSESSOR-COLLECTOR TO ASSESS, ACCOUNT FOR, AND
DISTRIBUTE THE PROPERTY TAXES AS HEREIN LEVIED.**

**NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF
VON ORMY, TEXAS:**

Section 1: The assessment roll for 2013 for the City of Von Ormy as compiled by Bexar County Appraisal District and as amended by the Appraisal Review Board is hereby approved and adopted.

Section 2: That there be and there is hereby levied and ordered collected the sum of \$0.255 ad valorem tax on each One Hundred Dollar (\$100.00) valuation of all taxable property, real, personal and mixed, within the corporate limits of the City of Von Ormy, Texas on January 1, of 2013, for the following purposes and in the following amounts:


Debt Service Requirements: \$0.00
Maintenance & Operations: \$0.255
Total Tax Rate Per \$100.00: \$0.255


Section 3: There shall be a reduction of \$5,000.00 from the value assessed for all taxable property, real, personal and mixed, for owners over 65 years of age.

Section 4: Said ad valorem taxes shall be due and payable at the time and in the manner provided by the City of Von Ormy's ordinance relating to the payment of ad valorem taxes which said ordinances provide for penalties and interest on delinquent taxes.

Section 5: That this ordinance shall become effective immediately after passage.

Section 1: The assessment roll for 2013 for the City of Von Ormy as compiled by Bexar County Appraisal District and as amended by the Appraisal Review Board is hereby approved and adopted.

Section 2: That there be and there is hereby levied and ordered collected the sum of \$0.255 ad valorem tax on each One Hundred Dollar (\$100.00) valuation of all taxable property, real, personal and mixed, within the corporate limits of the City of Von Ormy, Texas on January 1, of 2013, for the following purposes and in the following amounts:


Debt Service Requirements: \$0.00

Total Tax Rate Per \$100.00: \$0.255


Section 3: There shall be a reduction of \$5,000.00 from the value assessed for all taxable property, real, personal and mixed, for owners over 65 years of age.

Section 4: Said ad valorem taxes shall be due and payable at the time and in the manner provided by the City of Von Ormy's ordinance relating to the payment of ad valorem taxes which said ordinances provide for penalties and interest on delinquent taxes.

Section 5: That this ordinance shall become effective immediately after passage.
