

CITY OF VON ORMY
ORDINANCE NO. 2025 -02

AN ORDINANCE CANVASSING RETURNS OF THE MAY 3, 2025, GENERAL ELECTION WHICH WAS CONDUCTED JOINTLY WITH OTHER ELECTIONS IN BEXAR COUNTY FOR THE PURPOSE OF ELECTING CANDIDATES TO THE BOARD OF COMMISSIONERS OF THE CITY OF VON ORMY, TEXAS AND PROPOSITION A ON THE ABOLITION OF SALES AND USE TAX FOR THE FOR THE MAINTENANCE AND REPAIR OF MUNICIPAL STREETS COMBINED WITH THE ADOPTION OF A SALES AND USE TAX FOR THE CITY'S REGULAR SALES AND USE TAX RATE UNDER TEXAS TAX CODE; DECLARING THE RESULTS OF THAT ELECTION; PROVIDING A SEVERABILITY CLAUSE; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, an election was held in the City of Von Ormy, Texas on May 3, 2025, for the purpose of electing a Mayor and elect two (2) Commissioners Place 1 and Place 2, and for the election of Proposition A on the abolition of sales and use tax for the for the maintenance and repair of municipal streets combined with the adoption of a sales and use tax for the city's regular sales and use tax rate under Texas tax code.

WHEREAS, The Board of Commissioners have reviewed and investigated all matters pertaining to this election, including the ordering, notices, election officers, holding, and returns thereof: and

WHEREAS, The Board of Commissioner hereby canvasses the returns of this election, at which there was submitted to all residents, qualified electors of the City for their action thereupon, the election of Mayor, Two Commissioners Place 1 and Place 2 and Proposition A.

WHEREAS, from these returns, the Board of Commissioners hereby find that the following voters who were residents, qualified electors of the City and

WHEREAS, Proposition A and each of the candidates in said election received the following votes:




THEREFORE BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF VON ORMY THAT:


