The purpose of this letter is to inform you of the Commission's decision to propose termination of your employment as City Clerk. The Commission identified the following reasons for your termination:

- Incompetence.
- 2. Corruption.
- 3. Misconduct.
- 4. Malfeasance.

Your dismissal is based upon the Commission's complete loss of trust and confidence in your ability to exercise sound judgment, display honesty and integrity in your actions, and perform your duties with the necessary degree of competence. I discovered countless alarming financial irregularities, inexplicably excessive payments to unknown individuals, unjustified payments to yourself and family

members, and numerous accounting and tax errors that I reported to the Commission. Your acts and omissions have generated deep mistrust from myself and the Board of Commissioners, which resulted in the Commission voting to initiate removal proceedings against you.

Although you have already been afforded an opportunity to address the Commissioners in Executive Session at the May 19, 2023, special meeting, you are served with this additional notice and opportunity to be heard again before the Commission takes final action at the regular meeting scheduled on June 15, 2023.
