

CITY OF VON ORMY, TEXAS

ORDINANCE NO: 2010-45

AN ORDINANCE ESTABLISHING A MASTER FEE SCHEDULE FOR REGULATING AND ASSESSING FEES; PROVIDING FOR COLLECTION OF FEES; REPEALING ANY ORDINANCE IN CONFLICT WITH THE MASTER FEE ORDINANCE; PROVIDING FOR SEVERABILITY; FIXING A PENALTY FOR VIOLATION THEREOF; AND PROVIDING AN EFFECTIVE DATE

WHEREAS, the City of Von Ormy finds a Master Fee Schedule has been prepared and presented to the City of Von Ormy which lists the majority of fees that are assessed to cover the costs associated with the efficient operation of the City; and

WHEREAS, after careful consideration of the financial plan and City Services, the City of Von Ormy has determined that the public welfare would be best served by establishing a Master Fee Schedule.

NOW, THEREFORE BE IT RESOLVED AND ORDERED BY THE CITY COUNCIL OF THE CITY OF VON ORMY TEXAS, THAT:

Section 1: FEES

Animal Boarding, Quarantine and Euthanasia

Animal Boarding and Quarantine	Cost to the City plus 15% administrative fee
Animal Euthanasia	Cost to City plus 15% administrative fee

Animal Registration Tags

Non-Spayed/Neutered Dog	\$30.00 per animal annually
Spayed/Neutered Dog	\$10.00 per animal annually
Replacement Tag	\$5.00 per animal annually
Dangerous Animal	\$250.00 per animal annually
Prohibited Animals	\$250.00 per animal annually

No charge for Spayed/Neutered Pet License if one of the following conditions are met:

- Owner is 60 years of age or older
- Owner can provide proof of receiving financial assistance from any government agency due to disability or low income
- Animal is being used by a law enforcement agency
- Animal is a certified assistance animal


Section 2. REPEAL OF CONFLICTING ORDINANCES. This ordinance shall be and is hereby declared to be cumulative of all ordinances of the City of Von Ormy and this Ordinance shall not operate to repeal or affect any such other ordinance except insofar as the provisions thereof might be inconsistent or in conflict with the provisions of the Ordinance, in which event such conflicting provision, if any, in such other ordinance or ordinances are hereby repealed. Regulation in regard to enforcement of the fees herein is contained in the various instruments of legislation adopted by the City Council of Von Ormy.

Section 3. SEVERABILITY. If any section, subsection, phrase, sentence or portion of this Ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distance than independent provision and such holdings shall not affect the validity of the remaining portions thereof.


Section 4. PENALTIES. A person or company who commits a violation of any section or subsection of this ordinance shall be punishable by a fine of not more than one thousand dollars (\$1,000.00) for each violation. Each and every day of violation shall constitute a separate offense.

Section 5. EFFECTIVE DATE. That the City of Von Ormy City Clerk is hereby ordered and directed to cause this ordinance to be published in every issue of the official newspaper for two days; or one issue of the newspaper if the official newspaper is a weekly paper. This ordinance and the rules, regulations, provisions, requirements, orders, and matters established and adopted hereby shall take effect and be in full force and effect when the publication requirement is satisfied..
