THE CITY OF VON ORMY**



- 1) Discuss, consider, and take possible action to approve an interlocal grant agreement between the County of Bexar, Texas, and the City of Von Ormy, Texas, for the distribution of federal coronavirus relief funds; to authorize Mayor, or Mayor's designee, to negotiate and execute such interlocal agreement; to authorize Mayor, or Mayor's designee, to negotiate and execute any and all related documents and certificates necessary for such interlocal agreement; to authorize Mayor, or Mayor's designee, to take any and all other actions necessary for such interlocal agreement; and to authorize all other related matters.
 - 2) Discuss, consider, and take possible action to approve a resolution approving an interlocal agreement to accept federal coronavirus relief funds from the County of Bexar, Texas, for the City of Von Ormy, Texas; to authorize said City's Mayor, or Mayor's designee, to negotiate and execute such resolution; to authorize Mayor, or Mayor's designee, to take any and all other actions necessary for such resolution; and to authorize all other related matters.
 - 3) Discuss, consider, and take possible action to approve an interlocal agreement for designation of County of Bexar Health Authority for the City of Von Ormy, Texas, pursuant to Texas Government Code Chapter 791 and Texas Health and Safety Code Chapter 121 in order to protect the health and safety of the public throughout Bexar County, Texas, and said City; to authorize said City to designate and appoint Dr. Chichi Junda Woo, M.D., to serve said City as its Health Authority pursuant to Texas Health and Safety Code Chapter 121; to authorize Mayor, or Mayor's designee, to negotiate and execute such interlocal agreement; to authorize Mayor, or Mayor's designee, to execute a Certificate of Appointment for a Health Authority; to authorize Mayor, or Mayor's designee, to take any and all other actions necessary for such interlocal agreement; and to authorize all other related matters.
 - 4) Adjourn.
